A full scale replica of the Oval Office is a prominent feature of this museum as well. The hilltop grounds provide expansive views of the area, a re-creation of a portion of the White House Lawn, and a piece of the Berlin Wall. An F-14 Tomcat is also located on the grounds. A 90,000-square-foot exhibit hangar serves as the setting for the permanent display of the Boeing 707 aircraft utilized during Reagan’s administration.

The Tournament of Roses Parade in Pasadena, a grand tradition since 1890, is held every New Year's Day (except when it falls on a Sunday, it is held on Monday the 2nd). Local tradition has it that "the Tournament has a deal with God; we'll never hold the parade on a Sunday, and He'll never let it rain on the Rose Parade." Other lore has it this "Never on Sunday" policy was instituted in order "to avoid frightening horses tethered outside local churches and thus interfering with worship services." Thus, the parade has never been held on a Sunday. The Rose Bowl Game is also not held on Sunday to avoid competing with the NFL. When the parade debuted, 2,000 citizens were on hand to witness history in the making. Today, more than one million spectators line the parade route.
